


# "Faithful Administration and Governance: Defining and Measuring Success in the Ministry" Dr. Wesley K. Willmer and Dr. Gary G. Hoag



### Faithful Administration: Two Paths

The administration of God's work often follows one of two paths. The path is most often determined by how God's servants define and measure success in the ministry.

### The Common Path

- 1. Production-Driven Leadership
- 2. Expansion-Focused Strategies
- 3. Earthly-Oriented Metrics
- 4. Results-Based Management
- 5. Utilitarian View of Resources

## The Kingdom Path

- 1. Steward Leadership
- 2. Faithfulness-Focused Strategies
- 3. Eternity-Oriented Metrics
- 4. Relationship-Based Management
- 5. Stewardship View of Resources

### Fruitful Governance: Checklist

Governance corresponds to the administration of the ministry and how it defines and measures success. Faithful governance works through a checklist to ensure God's work stays on track.

- ✓ Discern the ministry mission and purpose
- ✓ Ensure effective organizational planning
- ✓ Reviews stewardship of resources
- ✓ Enhance the public standing of the ministry
- ✓ Maintains posture of transparency / accountability
- ✓ Select CEO / Chief Administrator
- ✓ Support the CEO / assess performance
- Monitors ministry programs and services
- Ensures legal and ethical integrity
- Recruit gifted board members

### Avoiding Three Temptations: Luke 4:1-13

Jesus overcame three temptations before His earthly ministry began. We must overcome resist the temptations of control (4:1-4), idolatry (4:5-8), and pride (4:9-13).

(9) Mobilizing Spiritually-Gifted People (10) Radical Christian Generosity
