Giving to ECFA Charities Remains STEADY After Six Years of Increases

Study of Nearly \$14 Billion in Cash Giving Reveals Significant Variation Across 26 Ministry Types

WINCHESTER, Va. – ECFA State of Giving 2019 reveals a pace in charitable giving that held steady with the giving rate of the previous year. After six years of annual increases (2011-2017), cash giving to ECFA members declined slightly -0.6% between 2017 and 2018, according to ECFA's inflation-adjusted analysis of \$13.9 billion in cash donations to 1,940 ECFA-accredited organizations. Cash gifts include cash, checks and electronic monetary contributions.

The rate was much stronger than the stock market, where the S&P 500 declined an inflation-adjusted 6.2% for the same time period. It was also healthier than Giving USA's national data on \$125 billion in contributions to religion, which declined 3.9% when adjusted for inflation. Wage growth during that period was also relatively flat at 0.9%.

What prevented a greater increase in the giving rate? "Changes in giving often parallel stock market trends, so this year's report is not a big surprise," said Dan Busby, ECFA president. "Another likely influence is the massive change in our income tax structure effective starting in 2018. We're still sorting out the impact of tax reform and likely won't fully know what it's meant to giving patterns until this time next year."

ECFA State of Giving 2019 breaks down giving into 26 ministry segments, which surfaced considerable variety between various types of ministry. The areas with the most growth from 2017 to 2018 are community development (26.6%), camps and conferences (23.1%), and medical, dental and health services (11.9%). Those with the greatest decline are church denominations (-11.1%), leadership training (-7.1%) and relief and development (-6.9%). All numbers have been adjusted for inflation.



What are the trends for 2019? In October, we asked ECFA members about year-to-date giving and 464 responded. When asked, "Please compare cash giving in Jan-Sept 2018 to Jan-Sept 2019," 74% reported that it has increased or held steady, while 26% said that 2019 is lower. This finding and other responses from the 2019 ECFA Member Financial Snapshot (a separate report downloadable at ECFA.org/surveys), give me hope that 2019's cash giving will be stronger than 2018's."

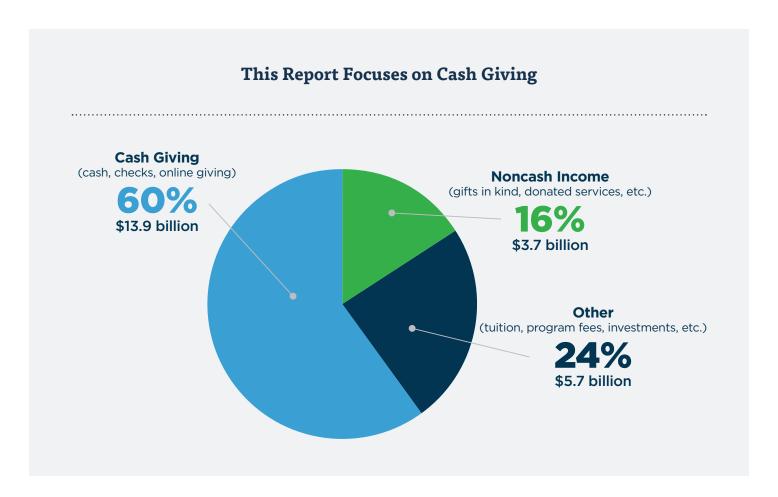
"Following a multiyear trend, smaller-budget ministries—those with annual revenue under \$1 million—again experienced a decrease in cash giving between 2017 and 2018. Interestingly, a decrease also happened with the biggest nonprofits—those with annual revenue of \$50 million and higher."

From 2008 to 2018, average cash giving to ECFA's total membership increased annually by an average of 1.8%.

"I am pleased to see this consistent support for Christ-centered churches and ministries," Busby added. "This generosity positions ECFA members to continue their positive impact for their causes both domestically and internationally."

Data used in ECFA State of Giving 2019 comes directly from its member financial statements—primarily audits, which are prepared by independent, certified public accountants.

This is the ECFA's 10th annual report on annual cash giving to ECFA-accredited organizations.

For example, all ECFA members must annually submit CPA-prepared financial statements. The terms ECFA member, accredited and certified are interchangeable.

In 2019, ECFA had more than 2,400 accredited members. Data in ECFA State of Giving 2019 is limited to those who have been members during both years being compared. Other variations are due to the addition of new members, exclusion of some members that renewed membership after the deadline for various reasons, and loss of other ministries that did not continue membership.

2017-2018 CASH GIVING IN SPECIFIC AREAS TO ECFA-ACCREDITED ORGANIZATIONS









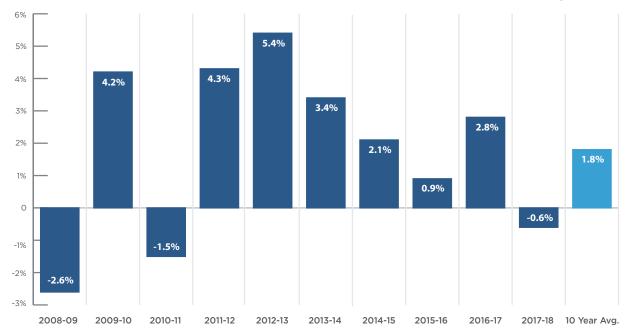
